Membership Fees

At the recent Annual General Assembly of Hel.A.S., where the level of fees was discussed, it was recommended that the registration fee and the annual membership fee for 2011, remain at the same level as in previous years. The fees are set to:

If you are uncertain whether you have outstanding fees from previous years, please contact the Treasurer of Hel.A.S. who can provide details on your financial status towards the Society. Please note that according to Article 32 of the Constitution of Hel.A.S., a member must have paid the current, as well as all outstanding annual membership fees in order to be eligible to vote. Furthermore, according to Article 13 of the Constitution, the Governing Council of the Society may remove the membership status from an individual if he/she has not paid his/her annual membership fee to the Society for more than 2 years.

Membership Classes

- **Ordinary member:** Open to any person holding a Ph.D. in Astronomy or closely related field, who is promoting Astronomy through his/her actions.
- **Junior member:** Open to any person, under 35 years old, studying the science of Astronomy or a closely related field as a postgraduate student.
- **Associate member:** Open to any person who, through his/her actions, promotes the science of Astronomy, but does not fulfill the requirements of an Ordinary or a Junior member.
